A. Meeting Called to Order by Dan at 7:05 P.M.
B. Reorganization of the Committee:

Dan took a few minutes to briefly explain the SSC positions and their responsibilities. SSC discussed which members were comfortable with taking on which positions.

for public education (and especially for small rural schools), and both of these opportunities will be helpful in that regard. Dan would like to attend both of these, and is fine with working out funding for other SC members who are interested; both Julie and Jen expressed an interest.

## G. Unfinished Business / Updates:

1. Capital Projects/Building Process - Discussion:

Dan has gotten information about using ARPA funds through the Town to pay for roof replacement and repair. The Town has apparently voted to use those funds, if available, for this purpose.

## H. New Business / Discussion Items:

1. Discussion of School Choice Funds:

Steve requested that some School Choice funds be given to the maintainers so that they can do some summer work that's outside the regular budget (landscaping work, mainly). Caitlin offered insight into the thinking that goes into how many seats are made available for Choice students in each grade each year. SSC explained to Jen how School Choice participation and funding works. Dan said we'd like to have some guidelines or guidance from Jennifer and Jackie to help us understand how best to use these funds to support the school.

## 2. Proposed School Committee Meeting Schedule FY23 - Discussion and Vote:

Dan said SSC normally meets every third Thursday of the month at 7 P.M. SSC discussed when they might meet in the coming year.

Caitlin said it's tragic when there's an incident with graffiti at any school. There are some Town funds earmarked for cameras at SSC to try to guard against this and other incidents. Dan shared information he has about various camera systems on offer. He recommends getting a couple of different camera companies in to compare their systems and pricing. Caitlin shared recommended limits that Dan suggested should be raised just in case. He hopes that the young people who committed the graffiti can be caught and learn why their actions are wrong.

Jackie has been working very carefully to make sure we're coming in in the black. It looks like we'll be okay, with no deficit, but that's thanks in large part to Jackie's careful management! No transfers will be needed at this point.

Steve reported that RSC has met once; the Superintendent Evaluation was a big part of that. Steve said that negotiations on the CES budget have been problematic. Dan noted that CES's COLA proposal was $2 \%$, not $7 \%$ as reported. Steve said fundraising has just started in earnest now for the track rehabilitation.
5. Union \#28 Report, including Budget \& Personnel:

Dan reported that U\#28 towns voted unanimously to adopt a 5-year rolling average as the basis for their contributions to the Union budget.
6. CES Report:

Dan reported that he attended the graduation ceremonies of the schools run and supported by CES and shared some heartwarming and inspiring stories about the students who graduated. These are very moving and emotional events. These schools are important to continue to support in the future.
