- Budget Update The School Committee is scheduled to meet with Fin Com March 5th 7:30 at the town hall. How much has changed since last meeting in the budget? Nothing.
- School Safety Management Some of the work has been done, but not all of it. Bob reported it is not going smoothly. He will attempt to enlist the help of the Police Chief to get the work done quicker by the contractor. Currently all the doors are locked during the day.

- Food Program/Breakfast Program Bob told the committee it is a roaring success! Fifteen kids have breakfast, and the program is making a little money. Dennise Forsman and Chrissie Bailey are staffing it and doing a very good job. Working well. Lunch is holding steady at 70-80's.
- Headstart MOU The committee was satisfied with the changes.

MICHAEL MOVED TO SIGN THE MOU, DAN SECONDED. FOUR APPROVED.

- Combined Meetings with Other U#28 Schools Michael said he does not support the plan. Emily felt it makes meetings less predictable and accessible. Dan happens to like the idea. Likes to visit other schools. The committee is satisfied meeting with Leverett once a year. The committee recommended to table this discussion until next month, when they will have a clear picture of how regionalization will precede.
- MSBA SOI Discussion Members of the Shutesbury Building Committee inspected the roof today. They would like to hire a roofing consultant because there is a possibility that a repair job could fix the problem rather than replacement.

Principal's Report Bob submitted his report to the committee. They had no further comments. The scheduled open house will help Bob to determine pre-school numbers and if there will be one or two pre-school classrooms next year.

Superintendent's Report Joan said she had nothing more to add from the packet she gave to the committee.

Regional School District Planning Board Report Forum held last night. Board will make recommendation on March 9th. The meeting is in the High School at 9am. A question was asked what would happen if Leverett voted to join the region and Shutesbury did not. What kind of financial impact would that have for Shutesbury? There was no further discussion on those issues.

Amherst-Pelham Representative's Report Michael described the cuts and additions proposed by the superintendent for the upcoming budget. He said there is a four town budget meeting this Saturday in Amherst at 2pm. Shutesbury proposed assessment is 4.07%. an increase of \$58,025. Amherst elementary school will eliminate early dismissal on Wednesdays and implement a new school time 8:50am till 3:10pm in order to comply with Time in Learning standards.
