## I. Reports:

1. Director of Finance and Operations Report: Jennifer reported that Bruce is at a conference, and that if we need to bounce some things around in the budget, we can address that at the June meeting. Jackie noted that for various staffing reasons, we have a decent amount of money we weren't expecting at this point, so we might not need to request as much money as we thought from the Town for our Out-ofDistrict placement.
2. Principal's Report: Jackie reported that the last day of school is Monday, June 25. Enrollment stands at 125 . We just sent out reminder letters for students and staff to pay their cafeteria bills. She explained the PTO "You've been MOOSED" campaign/game; a lot of families and kids are having a great time with it. The Spaghetti Dinner was a great success, raising over $\$ 3,000$. Lots of field trips are coming up, including a combined SES/LES Grade 3 trip to Plymouth Plantation. Jackie applied for lead and copper sampling and technical assistance provided by the Massachusetts Assistance Program for Lead in School Drinking Water. A student-run, teacher-supervised drama club has begun and is hard at work on an adaptation of The Jungle Book that will be performed on June 15. On the staffing side, Katie Hertel has been hired for the Grade 2 position out of over 70 candidates. Jen Culbreth is moving into the Reading Specialist / Title I position, and finalists are giving model lessons for the Grade 5 position.
3. Superintendent's Report: Jennifer reported that she'll be presenting her Summative Report along with artifacts and evidence this coming Monday. She spent a few days with members of the Leadership Team at the Presenter's Academy at CAS, focused on Universal Design for Learning. There was a large cross-section of people, mostly educators, including some from other countries. On the legislative horizon, several budget amendments addressing funding for rural districts loom large thanks to the work of the Rural School District Advocacy group as well as to our allies and representatives in the legislature. We are in the process of hiring a new Student Support Services Coordinator at Central Office; a new Executive Assistant has already been hired and will start after June 29.
4. Amherst-Pelham Representative's Report: Steve reported that two meetings ago, he'd reported on the public comments and roasting of the Superintendent over the hiring of the Interim Middle School Principal for the permanent position despite her not having a proper license. That's grown, but so has public support for the Principal, who has decided not to continue in the position. It turns out a number of other administrators lack the requisite licenses as well, which it is the duty of the Superintendent to verify. It's a big mess. They're trying to turn Dr. Patti Bodi into a "Teacher in Charge" or some other non-Principal position that would still keep her running the school. We're also trying to hire a new

Food Services Director since the current one is moving back East. He did get the new food program up and running and back into the schools, a great accomplishment.
5. Union \#28 Report - including Budget and Personnel: None.
6. CES Report: Dan reported that CES has not met since the last SSC meeting. We're doing the evaluation of the Executive Director with 22 out of 36 respondents. On Sunday he went to a student art show in Boston put on by the Student Services program, a phenomenal event.
